

Please read these Terms and Conditions carefully before enrolling in our tennis classes. By enrolling, you agree to be bound by the following terms and conditions:

1. Enrolment and Attendance: By enrolling in our tennis classes, you acknowledge that regular attendance is expected. It is your responsibility to attend the scheduled classes.
2. Travel and Absence: If you are unable to attend a tennis class due to travel plans, we can't offer you a make-up class.
3. Sickness or Court Closures/Cancellations: If a doctor's note is provided stating the injury or illness within 24 hours before or after the class or if poor weather or court closures don't allow the class to go ahead then a make-up class will be offered by GSTAHK. These are the only reasons for a Make-up class.
4. Make up class must be conducted in the current term in another viable class or the next preceding camp period. Any make up class that isn't used in the term period or following camp period will not be carried over into the next term and will be forfeited.
5. It is the responsibility of the student to attend the make-up class in the current term or next camp period - any make up class that isn't used in the term period or following camp period will not be carried over into the next term and will be forfeited.
6. Once a student has signed up to a GSTAHK Program no refunds will be given mid-term (Apart if there is serious injury or sickness - where a medical note is supplied for proof)
7. All Group lessons are billed on a termly basis with regards to the number of weeks in the school term, please check our calendar below, please note when GSTAHK Mid Term breaks will run. If you decide to join during the term - classes will be billed Pro rata for the rest of the weeks in that term. Please refer to Point no. 3 as to what covers a make-up class.
8. We ask that all students have their own racquet, upon request we can lend you a racquet for the first lesson but after which we ask that you purchase one best suited for you. We sell a variety of racquets based on ages, please check our website for our online shop.
9. All Trial classes (1 / first Class only) are Paid trial classes.

10. Termination or Suspension: We reserve the right to terminate or suspend your enrolment in the tennis classes if you fail to comply with these terms and conditions, including repeated unexcused absences or failure to provide proper notice of absence.

11. Our kids class sizes are 1 coach: 6 students, Our ladies' classes are 1 coach: 4 students.

12. All our classes (both Adult and Kids) are structured accordingly to level to the best we can. If you feel like you need your class adjusted, please speak to your coach for best class options.

13. If there is bad weather - ALL classes will be notified approximately 1 hour before start time.

14. We ask that all private lessons are conducted in a timing manner. Credits will expire 3 months from your last private lesson. Example, last lesson was 1st August - you will need to have at least 1 next lesson before the 1st of November to keep the credits active otherwise all credits remaining will be forfeited.

These Terms and Conditions constitute the entire agreement between you and Great Shot Tennis Academy Limited and supersede any prior agreements or understandings. We reserve the right to modify or update these terms and conditions at any time, and such modifications will be effective upon posting on our website or notifying enrolled participants.
